

Terms of Service (@November 28, 2025)

1. Introduction

The following terms and conditions (the "Terms" or "Ts&Cs") constitute a legally binding agreement between you ("you", "your", or "User") and **Twist of Fate Limited**, a Hong Kong company with registered office at RM 1505, 15/F., YU SUNG BOON BUILDING, 107-111 DES VOEUX RD CENTRAL, HONG KONG ("Collector Crypt on TON", "we", "us", or "our"), governing your access to and use of the Service (as defined below).

By accessing or using the website available at <https://collectorcrypt.tg> (the "Website"), the Telegram mini-app at <https://t.me/CollectorCryptBot> (the "Mini-App"), purchasing, selling, storing, redeeming, or otherwise interacting with any **Collector Crypt on TON NFT**, participating in the Gacha Machine, entering any raffle/sweepstake, or using any of our other services (collectively, the "Service"), you expressly acknowledge and agree that you have read, understand, and agree to be bound by these Terms.

If you do not agree to these Terms, you must not access or use the Service.

IMPORTANT NOTICE – ARBITRATION AGREEMENT

Section 14 contains a binding arbitration agreement and class action waiver. Unless you opt out within 30 days, it will require you to submit claims against us to binding individual arbitration and will prevent you from pursuing claims in court or as part of any class/representative action.

We may update these Terms at any time. We will notify you of material changes by posting the new Terms on the Website/Mini-App and updating the "Last updated" date. Your continued use after any update means you accept the changes.

2. Description of the Service

Collector Crypt on TON provides a platform on the TON blockchain where:

- Users can send physical Pokémon cards to us for professional vaulting and grading (where applicable).
- We mint a corresponding **Collector Crypt on TON NFT** that represents full ownership of the vaulted physical card.
- Users can hold, trade, redeem, or sell these **Collector Crypt on TON NFTs**.
- Users can purchase random vaulted Pokémon card **Collector Crypt on TON NFTs** via the Gacha Machine for a fixed price in USDT (price varies by collection and may change).
- From time to time we run raffles/sweepstakes with physical or digital prizes (see Section 15).

Collector Crypt on TON NFTs are collectibles only. They have no intrinsic value, are not investment products, do not represent any equity or profit-sharing right in Twist of Fate Limited or any affiliate, and are not redeemable for any guaranteed monetary amount. You acknowledge and agree that you have no expectation of profit from the efforts of the Company or any third party.

All **Collector Crypt on TON NFTs** are minted on and transferable via the TON blockchain. We do not custody your private keys or TON wallet.

3. Eligibility

You must be at least 18 years old (or the age of majority in your jurisdiction) to use the Service.

You must not be located in, or a resident/national of, mainland China, Hong Kong SAR, or Macau SAR.

By using the Service you represent and warrant that you are not located in or a resident/national of any of these prohibited jurisdictions.

4. Wallet Connection & Transactions

To use most features you must connect a TON-compatible wallet. All transactions (purchases, transfers, redemptions, etc.) occur directly on the TON blockchain via your wallet. We have no access to your private keys and cannot reverse transactions.

You are solely responsible for gas/network fees, maintaining wallet security, and any taxes.

5. Gacha Machine (Vending Machine / Drops)

- Purchases are made in USDT on TON at the price displayed at the time of purchase.
- Each purchase delivers one random vaulted Pokémon card **Collector Crypt on TON NFT**.
- The specific card received is random; no selection is possible.
- All purchases are final and non-refundable.
- Upon receipt you may (i) hold the **Collector Crypt on TON NFT**, (ii) list it on secondary markets, (iii) redeem the physical card (shipping fees apply, payable by you), or (iv) accept any instant buyback offer we may make (best-effort, time-limited, at our sole discretion).
- We make no guarantee of the card's value, rarity, or that a buyback offer will be available.

Collector Crypt on TON NFTs are collectibles only. They have no intrinsic value, are not investment products, do not represent any equity or profit-sharing right in Twist of Fate Limited or any affiliate, and are not redeemable for any guaranteed monetary amount.

6. Physical Card Vaulting & Redemption

When you send us a physical Pokémon card, we will vault it and mint a corresponding **Collector Crypt on TON NFT** representing ownership. You may later redeem any **Collector Crypt on TON NFT** you own for the physical card. Redemption requires:

- Verified identity and ownership of the **Collector Crypt on TON NFT**
- Payment of shipping, handling, customs duties, and any applicable taxes (at your expense)

Once shipped, the **Collector Crypt on TON NFT** is burned. We are not liable for loss/damage after handover to the carrier. We maintain insurance on vaulted cards while in our possession (excluding gross negligence or willful misconduct on our part).

7. Secondary Sales & Future Fees

You may sell **Collector Crypt on TON NFTs** on any TON-compatible marketplace. We currently do not charge any royalty or transaction fee on

secondary sales, but we reserve the right to introduce creator royalties or transaction fees in the future via smart-contract update or these Terms.

Company reserves the right, in its sole discretion, to block, burn, or otherwise restrict access to any **Collector Crypt on TON NFT** if it reasonably believes such NFT was obtained fraudulently, through breach of these Terms, or involves counterfeit/stolen property.

8. User Representations & Warranties

By using the Service you represent and warrant that:

- You are at least 18 and have full legal capacity.
- All information you provide is accurate.
- You are not located in or a resident/national of mainland China, Hong Kong SAR, or Macau SAR.
- You will not use the Service for money laundering, terrorist financing, fraud, or any illegal purpose.
- You will comply with all applicable tax obligations.
- You have no expectation of profit from the efforts of the Company or any third party.

9. Intellectual Property

All content on the Website and Mini-App (logos, designs, text, etc.) is owned by us or our licensors. You are granted a limited, revocable, non-commercial license to view and use the Service. You may not copy, modify, or create derivative works without our written permission.

10. Prohibited Conduct

You agree not to:

- Use bots, scripts, or automation to interact with the Service.
- Engage in wash trading, front-running, pump-and-dump, or any manipulative activity.
- Attempt to hack, DDoS, reverse-engineer, or interfere with the Service.
- Use the Service for any illegal purpose.

We may suspend or terminate your access at any time for violation.

11. Disclaimers & Limitation of Liability

THE SERVICE IS PROVIDED "AS IS" WITHOUT WARRANTIES OF ANY KIND. WE DO NOT GUARANTEE UPTIME, CARD VALUES, NFT TRANSFERABILITY, OR THAT THE TON BLOCKCHAIN WILL FUNCTION ERROR-FREE, OR THAT ANY COLLECTOR CRYPT ON TON NFT WILL RETAIN OR INCREASE IN VALUE.

Collector Crypt on TON NFTs are collectibles only and are not an investment. There is no guarantee of any future airdrops, rewards, incentives, or other benefits. Any such future events are at the sole discretion of the Company and are not guaranteed.

TO THE MAXIMUM EXTENT PERMITTED BY LAW, OUR TOTAL LIABILITY TO YOU SHALL NOT EXCEED THE AMOUNT YOU PAID US IN THE PAST 12 MONTHS (OR US\$100 IF NO PAYMENTS WERE MADE).

WE ARE NOT LIABLE FOR INDIRECT, CONSEQUENTIAL, OR PUNITIVE DAMAGES, EVEN IF ADVISED OF THE POSSIBILITY.

12. Indemnification & Release

You agree to indemnify and hold us harmless from any claims arising from your breach of these Terms, your use of the Service, or your violation of any law.

You hereby release and forever discharge us (and our officers, employees, agents, successors, and assigns) from, and hereby waive and relinquish, each and every past, present and future dispute, claim, controversy, demand, right, obligation, liability, action and cause of action of every kind and nature (including personal injuries, death, and property damage), that has arisen or arises directly or indirectly out of, or that relates directly or indirectly to, the Service.

IF YOU ARE A CALIFORNIA RESIDENT, YOU HEREBY WAIVE CALIFORNIA CIVIL CODE SECTION 1542 IN CONNECTION WITH THE FOREGOING, WHICH STATES: "A GENERAL RELEASE DOES NOT EXTEND TO CLAIMS WHICH THE CREDITOR DOES NOT KNOW OR SUSPECT TO EXIST IN HIS OR HER FAVOR AT THE TIME OF EXECUTING THE RELEASE, WHICH IF KNOWN BY HIM OR HER MUST HAVE MATERIALLY AFFECTED HIS OR HER SETTLEMENT WITH THE DEBTOR."

13. Copyright Infringement (DMCA)

14. Governing Law & Dispute Resolution

These Terms are governed by the laws of Hong Kong SAR (without regard to conflict of laws principles).

Any dispute arising out of or relating to these Terms or the Service shall be finally settled by binding arbitration administered by the Hong Kong International Arbitration Centre (HKIAC) under its rules in force when the notice of arbitration is submitted. The seat of arbitration shall be Hong Kong. There shall be one arbitrator. The language shall be English.

You and we both waive any right to participate in class/collective actions. You may opt out of arbitration by sending written notice to contact@collectorcrypt.tg within 30 days of first accepting these Terms.

15. Raffles / Sweepstakes Official Rules (General)

From time to time we run promotional raffles/sweepstakes ("Promotions"). Each Promotion is governed by these general rules plus any specific Official Rules posted for that Promotion.

No purchase necessary. Purchases do not increase odds.

Eligibility: 18+, not resident in mainland China, Hong Kong SAR, or Macau SAR. Void where prohibited.

Compliance and Disqualification: We reserve the right to disqualify any participant (and void or remove their entries) who tampers with the entry process, attempts to circumvent the AMOE or any Promotion rules, uses bots or other automation, violates our Terms, or engages in fraudulent, unethical, or malicious behavior. Our decisions on disqualification are final.
